What is Gift Aid?

Gift Aid is a scheme that HMRC runs to help charities make their donations go further. It allows charities to claim the basic rate tax on every pound donated. This means that for every pound donated, we can reclaim an extra 25p.



- **1.** Ask every adult donor (who is a tax payer) to write their full details and tick the Gift Aid box to increase their donation at no extra cost.
- 2. Each person much write their details in their own handwriting so that we can claim the Gift Aid.
- 3. Send us your completed form in the Freepost envelope included in this pack, along with the 'What you've raised' form.
